



Description of alternative hybrid approach with the picture which shows the sections please

The alternative hybrid approach comprises:

- Procurement of three design and build contracts, for (in order of procurement):
 - Tay Crossing to Ballinluig (P3);
 - Pitlochry to Killiecrankie (P4); and
 - Pass of Birnam to Tay Crossing (P2) (Subject to completion of statutory processes).
- Subject to further decision making in late 2025, procurement of two mutual investment model contracts, for (in order of procurement):
 - A9 North, comprising Crubenmore to Kincraig (P9) and Dalraddy to Slochd (P11); and
 - A9 Central, comprising Killiecrankie to Glen Garry (P5), Glen Garry to Dalwhinnie (P7) and Dalwhinne to Crubenmore (P8).
- This further decision making will be based on due diligence of market conditions prevailing
 at the time, and what they are likely to mean for affordability and VfM of the MIM option vs.
 continuing with Capital funded D&B contracts. As well as market conditions, the overall
 Scottish Government Resource Budget will need to be in balance and able to absorb the
 projected annual service payments under a MIM contract.





Costs – spend to date and anticipated spend including with detail on comparison with 2008 (£3bn at 2008 prices explanation)

Updated costs have been calculated on a "total scheme cost" basis, which is the same basis as the original estimate of £3bn at 2008 prices was prepared.

A total scheme cost includes costs of preparation, completion of statutory processes, land acquisition, procurement and construction. It does not include future operation and maintenance costs.

Up to 18 October 2023 a total sum of approximately £460m had been spent on the A9 Dualling programme. This differs from a figure for spend to date of approximately £451m included in a recent Fol response, with the difference arising from identification of a cost line that was inadvertently excluded from the Fol response.

Updated estimates, prepared at April 2023 prices, indicate that further total scheme costs of approximately £3,247m will be incurred in completing the programme.

This gives an updated total scheme cost for the A9 Dualling Programme of £3,707m at April 2023 prices, which has been rounded to £3.7bn at April 2023 prices for communication purposes.

When costs spent to date and expected future costs are discounted to 2008 prices using the Consumer Price Index measure of inflation, the £3,707m at April 2023

prices is equivalent to £2,454m at April 2008 prices, which has been rounded to £2.45bn at April 2008 for communication purposes. This figure is well within the original estimate of £3bn at 2008 prices.

The original Hybrid Option considered was developed in response to a request from Mr Dey, the then Minister for Transport, to consider whether such an approach could enable an earlier completion date to be achieved than the dates offered by the other options identified at that time.

Achieving an earlier completion date required acceleration of the programme by undertaking a larger amount of concurrent working, leading to concerns regarding market capacity to deliver and the extent of disruption that would result for road users. Transport Scotland concluded that these factors were of such significance that the approach could not be recommended.

The later Hybrid and Alternative Hybrid Options considered do not involve the same extent of concurrent working as the original Hybrid Option, and therefore the concerns expressed in relation to the original Hybrid Option are not applicable in a similar manner to these later Hybrid Options.
