#### OFFICIAL & NATIONAL STATISTICS FOR SOCIAL SERVICES 2017

#### 1. INTRODUCTION

This letter provides details of all Social Care surveys which are due for completion and return during 2017. It does not include surveys relating to Children and Families or Criminal Justice. # 2. WHAT DO I NEED TO DO?

You should note the deadlines for all surveys (set out in Annex C) and particularly the deadline of <u>31<sup>st</sup> July 2017</u> for the Social Care Survey and Learning Disability Statistics. It is important that Local Authorities meet these deadlines so that the various Official Statistics producers can in turn meet the pre-announced schedule for publication of National Statistics.

#### 5. WORK PLAN FOR NEXT YEAR

In addition to routine publications, over the coming year our focus will be on:

- Working closely with ISD, SCLD and partnerships along with data users and providers
  to develop a single Social Care Data collection which meets all user needs. We will
  be writing separately to you about this and the work will begin with a full user
  consultation on Social Care data needs.
- Working with health and social care partnerships, local authorities and carers centres
  to develop the new Carers Census which will provide evidence to monitor the impact
  of the Carers Act.
- Developing a <u>Tableau</u> publication for when we publish Free Personal and Nursing Care as well as the usual Excel spreadsheet. We will consult with users on their publication preferences going forward.
- Indexing the Social Care Survey data for 2010 2016. This will allow linkage of Social Care Survey to other data sources to produce anonymised data for 'statistics and research' purposes. Researchers can apply through the Public Benefit and Privacy Panel for Health and Social Care (PBPP) to access and analyse this data.

#### Social Care Services, 2016-17

There are no changes to the Social Care Survey for 2016-17. The 2016-17 Survey includes sections on:

# Census week (including 31st March) 2017:

The Social Care Survey should be returned to the Scottish Government by the end of July 2017 using the ProcXed system, which ensures a secure route for data transfer. # **Quarterly Monitoring Return, 2016-17**

In 2017, the quarterly monitoring return will continue to focus on the collection of Eligibility Criteria and Waiting Times data for the Jan-March quarter.

The Jan-March 2017 quarter will also ask for care homes data on the number of long stay residents and those receiving FPNC within a care home. This information will be published in the annual Free Personal and Nursing Care publication.

### Learning Disability Statistics Scotland, 2016-17

The Scottish Commission for Learning Disability are responsible for the publication of Official Statistics on adults with learning disabilities and/or on the autism spectrum known to local authorities in Scotland. Their publication was granted National Statistics status in 2015.

Their publication is the main source of data on adults with learning disabilities and/or on the autism spectrum known to local authorities in Scotland and is widely used by policy makers and analysts within Scottish Government. It is vital, therefore, that their collection deadlines are met.

Last year we held an event to discuss how best to minimise duplication between the Social Care Survey and the Learning Disability Statistics:

The changes resulting from that event are:

- The data collection period for LDSS has changed to mirror the Social Care Survey this means the data collection period runs from 1st April 2017 to 31st July 2017
- LDSS now asks for the records of people with whom there was contact with in the last 12 months, not the last three years as it previously was
- LDSS is now asking for full Date of Birth as opposed to Year of Birth
- Postcode is now a mandatory field
- LDSS will not ask for Self-directed Support this year
- LDSS will ask for the equivalent Social Care ID Number of the people in the return as well as the LDSS ID Number they have been assigned. This will allow the Self-directed support data from the Social Care Survey to be linked with the Learning Disability statistics.

# Local Authority Social Work Services (LASWS), 2016

The LASWS return covers all staff working in local authority social work services who are not part of a registered care service. Further detail on those workers who are Mental Health Officers (MHO) is also collected. The 2016 annual MHO report and annual Scottish Social Services Workforce Data (SSSWD) report are both due to be published in August 2017. Data collection for these reports is already underway. The reference date for the 2017 data collection is Monday 4 December 2017, with data due by Friday 9 March 2018.

### Carers Census \*\*NEW\*\*

A short life working group chaired by Social Work Scotland and consisting of partnerships, carers centres, National Carers Organisations, Scottish Government and carers was set up in June 2016 to develop data specification and guidance for a new data collection on support to carers. This is being introduced to monitor the impact of the Carers Act and has the support of COSLA and Social Work Scotland.
